ST. MARY'S ANNOUNCES POLICY FOR FREE, REDUCED-PRICE MEALS

NORFOLK, Va. (July 9, 2014) — St. Mary's Home today announced its policy for meals served to children under the National School Lunch and/or School Breakfast Programs. A copy of this policy is on file at the Home and may be reviewed by any interested party.

This program receives some support from the federal government. Although all children receive the meals at no charge, the household size and income criteria will be used to determine the number of children eligible for free or reduced-price meals. The result of this process will determine the amount of support received from the federal government. See the Income Eligibility Guidelines attached.
